

2025 Coastal Acres Campground Pet Policy for Rental Campers

We are looking forward to your arrival staying in one of our Pet Friendly rental campers! We aim to make your stay enjoyable for both you and your beloved pets. As such, we would like to take this opportunity to clearly lay out our policies and expectations for you as pet owners to ensure that everyone will be able to have an enjoyable stay.

Please read in full, accept the rules and electronically sign and date the form. Failure to reply with acceptance may result in cancellation of your reservation.

1. Up to two, 35lb pets are allowed in designated Rental Camper Unit T13 or T16, so long as they are at least one year old, well-behaved, house-trained (not allowed on furniture), vaccinated, and actively treated for ticks and fleas. Vaccination records and current Rabies certificate must be emailed to coastalacresptown@gmail.com prior to your arrival. Pet 'pee pads' are not allowed. I confirm that my pet has all the required up to date vaccinations and inoculations and does not have any communicable illnesses or diseases.
2. You are responsible for cleaning up after your pet inside the camper, on the property and in the neighborhood. Plan to bring your cleaning agents and anything you know you will need to clean up after your pet. There are multiple pet waste stations all around the campground to obtain waste disposal bags and deposit your pets' waste. Please utilize these stations.
3. I agree to assume full responsibility for any injury or damage caused or alleged to be caused by my pet and incurred by any guest or employee of Coastal Acres Campground. I agree to indemnify, defend and hold harmless Coastal Acres Campground from and against all alleged or actual losses, claims, damages, liabilities, costs and expenses (including attorney's fees and court costs) suffered by Coastal Acres Campground or asserted by any other campground guest or employee or person arising out of or in connection with my pet's stay at Coastal Acres Campground. I agree that if my pet(s) bite someone, the Provincetown Animal Control officer or Provincetown Police Department may require quarantine for a minimum of 10 days. I acknowledge that I will need to vacate the Coastal Acres rental camper immediately and understand all reservation monies paid may be forfeited.
4. Pets cannot be left in this camper unattended at any time. If you intend to go out, plan on bringing your pets with you. There are many dog-friendly eating establishments where outdoor seating is available, as well as a beautiful dog park and many places to walk your dog. (If your dog is heard barking and in distress inside the camper, we will contact you by phone immediately. You are expected to address this issue immediately as it may be disturbing other guests. If it is found that you have left your pet unattended in the camper it may be grounds for immediate expulsion with no refund) Pets left alone in strange, new surroundings often become stressed and may become destructive to their environment. Destruction of property within the camper may result in forfeiture of a portion or all of your \$500 deposit. If the deposit is exceeded, you agree to Coastal Acres charging your credit card on file for the difference due.
5. Dogs must be always kept on a leash with a maximum 6ft lead. Dogs are not allowed to roam freely around the campground or site. We also have wildlife such as foxes, raccoons, deer and

Coywolves that may go after your smaller size pets. We want to make sure that your Fur babies are kept safe from harm and return home with you after your visit.

6. Please avoid bringing your dog into the pond at the back of the property. Due to the wildlife and plant habitat of the rare and fragile Quaking Bog aka Shank Painter Pond, no person or domestic animal is allowed in or around the bog. It is protected in perpetuity exclusively for conservation purposes and not to be used for any type of recreation.

These guidelines are in place so all campers can enjoy their camping experience. You will be asked to leave if these guidelines are not followed.
